The Personal Representative has appeared to disburse to Lake Station collectively in two entries some \$1,474.00 for garbage and water bills. However, the actual amounts paid according to the bills, before late fees chargeable to the estate were \$1,162.30, not 1,474.00 based on the receipts provided by the Personal Representative.

k. George Gancarz - Home Repairs

The Personal Representative has appeared to disburse to George Gancarz some \$11,726.00 apparently for home repairs due to the decedent's passing. However, the Personal Representative has failed to provide any contract, invoices, or billings concerning the same as required by I.C. 29-1-16-5 and Local Probate Rule 15. There are no time sheets or really anything to support this amount. Moreover, these materials were requested in discovery from the Personal Representative, which the Personal Representative has declined to respond to.

1. Terry Hansen - Home Repairs

The Personal Representative has appeared to disburse to Terry Hansen some \$1,800.00 apparently for home repairs following the decedent's passing. However, the Personal Representative has failed to provide any contract, invoices, or billings concerning the same as required by I.C. 29-1-16-5 and Local Probate Rule 15. Moreover, these materials were requested in discovery from the Personal Representative, which the Personal Representative has declined to respond to.

Moreover, Mr. Hansen did little work and was fired from the job. There are no time sheets or really anything to support this amount.

m. Krieg DeVault LLP - Legal Fees

The Personal Representative has appeared to disburse to Terry Hansen some \$1,800.00 apparently for home repairs following the decedent's passing. However, the Personal Representative has failed to provide any contract, invoices, or billings concerning the same as required by I.C. 29-1-16-5 and Local Probate Rule 15. Moreover, these materials were requested in discovery from the Personal Representative, which the Personal Representative has declined to respond to.

the Personal Representative's final account. In order to further resolve any confusion to the Personal Representative's final account, all NIPSCO bills pertaining to this estate are attached hereto and made a part hereof as Exhibit "G," and total \$4,501.72.

j. Town of Cedar Lake garbage and water fees

Attached hereto and made a part hereof as Exhibit "H" are invoices for garbage and water to the decedent's residence incurred by the estate after the decedent's death. The Personal Representative maintained utilities at the home. David Bolin used the decedent's home to celebrate his family's Thanksgiving, and he and his family lived at the decedent's home for a week at Christmas. While the home was being used by David Bolin, he fully utilized the garbage pick-up and water service. The invoices attached hereto for garbage and water bills total \$1,323.40.

k. George Goncarz – home repairs

George Gancarz made repairs to the decedent's home after the decedent's death.

David Bolin continually pushed the Personal Representative to hire George

Goncarz to make repairs to the decedent's home. David Bolin is very much

aware of what repairs were made to the decedent's home. The Personal

Representative paid George Goncarz \$4,805.00 for materials and \$6,920.00 for labor for repairs made to the decedent's home.

1. Terry Hansen - home repairs

Terry Hanson was hired by the Personal Representative in order to finish repairs to the kitchen walls of the decedent's home that David Bolin tore out without the permission of the Personal Representative. After George Goncarz completed all

Bolin proceeded to go into the decedent's home and tear out the kitchen walls.

David Bolin then attempted to re-plaster the kitchen walls for a day and then announced to the Personal Representative that he did not have sufficient time to finish the job and left the decedent's home. The Personal Representative hired Terry Hansen to repair the kitchen walls. Terry Hansen was not fired by the Personal Representative and sufficiently finished the job requested of him. David Bolin is fully aware of the estate's need to incur this expense and knows that his statement that "Mr. Hansen did little work and was fired from the job" is incorrect.

m. Krieg DeVault LLP - legal fees

The Personal Representative has filed a Petition for Fees with this Court.

- n. <u>Marjorie M. Zemkewicz personal representative fees</u>

 The Personal Representative has filed a petition for fees with this Court.

The Personal Representative has submitted a copy of all invoices and receipts in the Personal Representative's possession as part of the Personal Representative's final account and this pleading. If necessary, the Personal Representative is able to obtain copies of cancelled checks as further evidence of payment from this estate, but since many of them were issued over two years ago, there is a Five Dollar (\$5.00) charge per check. Estimated charges to obtain copies of checks for those disbursements questioned by David Bolin is approximately One Hundred Dollars (\$100.00.) If such checks are requested by David Bolin, the Personal Representative requests that the fees incurred to obtain copies of those checks be paid by David Bolin.
